



CHAIR'S REPORT MARCH 2016 – MAY 2017

Introduction

And so I come to the end of my third year as Chair of the Essex Clerks' Association; how time has flown and times have changed – yet again. The Association is now into its tenth year and this could be its most exciting. As many of you know, for fiscal reasons, the Essex Clerking Agency can no longer provide briefings for any other clerks except for those employed by them. When our Executive first heard this, we were extremely concerned that this would mean that very many clerks in Essex would then have no access to any form of training or briefings irrespective of whether they were prepared to pay or not.

Having spoken at length to the Clerking Service and to Clare Kershaw herself, I can confirm that our decision to support Essex clerks through our own briefing sessions (and potentially training sessions in the future) will be greeted very well and we were given their blessing.

These will be YOUR briefings – we want input from you so please do not hesitate to let us know what you need and we will do our utmost to provide it. For the time being, the briefings will be free of charge. We hope that, through our subscription of £15 a year, we will be able to continue to deliver them for free for as long as we possibly can.

I am also happy to report that, after a nightmare situation with our website, we have launched the new ECA site. It is still not completely up to date but we are doing our best and certainly by the beginning of next term, it will be fully functioning on all cylinders. Notes from these briefings with loads of attachments should be available in the next week or so.

We continue to have an excellent relationship with Essex Education Services, Governor Services and the Clerking Agency. However, the funding has finished and we have to stand on our two feet now.
